A. Texas Member Benefits - Melinda Daise

- **1. TSHA CE Registry** View your continuing education credits online through the TSHA website. When you attend a TSHA approved course, the hours you earn will be posted on a special page made available to you to print and send to the State Board of Examiners. **This benefit is available ONLY to TSHA members!**
- **2. Publications** The TSHA offers informative publications to its membership each year! As a TSHA member you will receive all of these publications at no charge.
 - The TSHA's newsletter, the *Communicologist* is published 6 times annually and includes current professional news, legislative updates, member news, continuing Education calendars and events, and much more!
 - Matt Learns to Read, TSHA members are entitled to 25 copies for their personal use. Available in English and Spanish. Must submit the registration form available on the TSHA website, <u>www.txsha.org</u> in order to receive books.
- **3. Continuing Education** TSHA's Continuing Education and Convention Committees work throughout the year to provide you with a challenging variety of seminars and workshops to help you maintain your Texas state license and your ASHA Certificate of Clinical Competence (CCC). ASHA will accept your TSHA registry as proof of your CEUs! **Remember that conference registration fees are considerable reduced for TSHA members.**
- **4. Speech Impairment Eligibility Guidelines** All of the SI Eligibility Guideline trainings are available as recorded webcasts online, along with the manuals and training handouts. SLPs can request 2 hours of TSHA continuing education credit for each of these trainings. **The cost is free for TSHA members.**
- **5. Online Ethics Course** This course presents the ethical issues information covered by the Code of Ethics from the Texas State Board of Examiners for Speech-Language Pathology and Audiology. Available on the TSHA website, www.txsha.org. Member price: \$40.00; Non-member price: \$75.00
- **6. Legislative Advocacy** The TSHA monitors administrative and legislative issues that affect you and your job. Issues such as reimbursement, quality of service delivery, and licensure.

- **7. Career Awareness Information** TSHA acknowledges that there is a shortage of speech-language pathologists and audiologists in Texas. To encourage students to pursue careers in the professions TSHA has developed a packet complete with brochures, pamphlets, bookmarks, and a career awareness DVD.

Students: In addition the above benefits, students receive special student-only membership benefits! Student membership is only \$25 per year, and student member Convention registration is only \$50! Potential members in or during their Clinical Fellowship Year (CFY) who were not student members of TSHA will receive a 25% active membership discount on their dues with documentation from the CF Supervisor stating that they are supervising the CFY. Students who have been members of the Association for 1 year will receive a 50% discount on their first year active or associate member dues. Students who have been members for 2 years will receive a 100% discount on their first year active or associate member dues.

The Tennessee Speech Hearing Association was founded in 1953 and became the Tennessee Association of Audiologists and Speech-Language Pathologists in 1974.

TAASLP Mission Statement:

To meet the needs of persons with hearing, communication, and swallowing disorders and to enhance the professional development of audiologists and speech-language pathologists.

Why TAASLP?

- 1) Professionalism TAASLP is the only organization in Tennessee that represents the interests of audiologists and speech-language pathologists and their clients. Its sole mission is "to meet the needs of persons with hearing, communication, and swallowing disorders and to enhance the professional development of audiologists and speech-language pathologists." Whether you are in private practice, a medical/hospital setting, public schools, or academia, it is essential that you stay abreast of developments in your profession and prepare for the future in today's increasingly competitive world. That is why hundreds across the state are members of TAASLP. They feel the involvement is critical to their careers, and they are given an opportunity to "give something back" to their profession by participating in TAASLP activities.
- 2) Advocacy TAASLP continually monitors legislation and regulations affecting the practice of audiology and speech-language pathology at the state and national levels. By staying in touch with legislators, testifying at committee hearings, or participating in letter writing campaigns, members have a tremendous impact on governmental issues. In 1999, TAASLP played a leading role in influencing Congress to place a two-year moratorium on the arbitrary \$1500 therapy cap and to provide new funding for newborn-infant hearing screening grants. In 2000, efforts were undertaken to extend the moratorium, reduce the caseload cap size, and repeal or reduce the annual professional practice tax in Tennessee. In addition to members' efforts, TAASLP employs a professional lobbyist to monitor legislation.
- 3) Education TAASLP provides its members with many opportunities for continuing education to help them keep up with advancements in diagnostics and treatment methods. Every year TAASLP offers an annual convention, and there are usually four other opportunities year-round. With the exception of convention, all continuing education activities are available to TAASLP members at no cost or at significantly reduced rates.
- 4) Networking When you attend a TAASLP meeting, serve on a committee, or participate in other activities, you have an excellent opportunity to interact with your colleagues one on one, share common interests and concerns, and network for employment and professional activities.
- 5) Information TAASLP publishes a newsletter, membership directory, and other materials to keep members informed on issues and developments affecting the practice of audiology and speech-language pathology. However, the most timely and accessible source of TAASLP information is its web center. The center provides members with updates on legislative and regulatory issues, job listings, publications, a calendar of events, message forum, leadership contacts, and valuable links to other professional websites
